## Notes on the processing of personal data

On our website, we process your personal data only if you have expressly consented thereto or you voluntarily provide your information. If you do not want to provide any data about yourself, the consequence is that usually no contract is possible (for example, lease, sales contract brokerage).

#### **Purposes**

We need your personal data:

when you visit our websites

- to analyse and optimize our website
- if you have consented to the sending of our newsletter
- if you would like to be contacted by us to get real estate offers for purchase and / or rental (purchase request or rental request)
- if you would like to be contacted by us to rent or sell a property
- if you specifically want to rent or buy a property (contract initiation)
- to settle possible liability claims as well as the assertion of any claims against you

The purposes stated here may also change. We collect only the data that is necessary for the respective purpose ("data minimization" according to Art. 5 para. 1 c EU-DSGVO). Your data will not be disclosed to third parties without your consent, unless this is necessary for the fulfillment of contractual or legal obligations. Your data will only be stored for as long as it is necessary for the respective purpose (Article 5 (1) EU-GDPR). Rules can be found in § 257 (1) No. 2 and 3 and § 257 (1) No. 1 of the German Commercial Code (HGB) and § 147 of the German Tax Code. The deadlines are usually between 6 and 10 years (in case of financial loss up to 30 years).

## What happens to your personal information?

Your visit to our site

As soon as you visit our website, access data will be saved in a log file. This file contains the browser type and version, the operating system you are using, the website from which you are visiting, the website you are visiting, the date and time of the access and your IP address. This processing is for monitoring our website, e.g. to detect possible errors in our websites. AllGrund does not associate the data contained in the log file with individuals. However, we reserve the right, in the event of certain facts, to suspect that users are using our pages and / or services in breach of the law or contrary to contract, to access the data. This serves to protect the AllGrund customers and users, the data and the AllGrund websites and services.

#### 1.2. tracking

Below we describe how your personal information is processed using tracking technologies to analyze and optimize our services and for promotional purposes.

The description of the tracking methods also includes information on how to prevent or contradict the processing of data. Please note that this so-called "opt-out", ie the rejection of processing, is usually stored via cookies. Tracking to analyze and optimize our services and their use

#### 1.2.1. Purpose of processing

It also serves to statistically determine parameters for the use of our services (range, intensity of use, user surfing behavior) on the basis of uniform standard procedures and thus to obtain comparable values ??across the market.

#### 1.2.2. Legal basis of processing

For services provided by us in connection with a contract, tracking and the associated analysis of user behavior are performed to fulfill our contractual obligations. The legal basis for this processing of personal data is Art. 6 I (b) GDPR. The evaluation of information obtained through tracking is necessary in order to provide you with optimized services according to the contractual purpose and to ensure you the greatest possible benefit. Otherwise, i. the legal basis for this processing of personal data is Article 6 (f) GDPR. With her, we pursue the legitimate interest in providing attractive services as efficiently as possible on the basis of the information gained through tracking and marketing this in the best possible way.

#### 1.2.3. The used tracking procedure in detail: Google Analytics

This website uses Google Analytics, a web analytics service provided by Google Ireland Ltd. (Gordon House, Barrow Street, Dublin 4, Ireland, ("Google"). Google Analytics uses so-called "cookies", text files that are stored on your computer and that allow an analysis of the use of the website by you. The information generated by the cookie about your use of this website is usually transmitted to a Google server in the USA and stored there.

However, as we have activated IP anonymization on this website, your IP address will be shortened by Google beforehand within member states of the European Union or in other contracting states of the Agreement on the European Economic Area. Only in exceptional cases will the full IP address be sent to a Google server in the USA and shortened there. X.1 Scope and description of the processing of personal data On our website you have the option of requesting an initial free indication of value for your property. For this purpose, we use an application of the specialist data provider Sprengnetter Real Estate Services GmbH ("Sprengnetter"), Sprengnetter Campus 1, 53474 Bad Neuenahr-Ahrweiler, HRB 27814, part of the Sprengnetter Group of Companies (info@sprengnetter.de). Sprengnetter and we have concluded an order processing agreement that ensures the handling of personal data within the legally prescribed framework of the DSGVO. To Sprengnetter's data protection declaration: https://www.sprengnetter.de/datenschutz/ Your data entered in the application is automatically transmitted to Sprengnetter and its group of companies for the purpose of creating the value indication. Sprengnetter expressly does not forward or use your data

for advertising or similar purposes. When using the application, the following information about the call is automatically processed by Sprengnetter: Date and time of the call, IP address, browser type and version, device type and the operating system. This data is only used for the provision of the application and is deleted after a few seconds and not used for any other purpose. Sprengnetter uses the services of the following providers within the scope of the application: - Mapbox, Inc. ("Mapbox") for address geocoding and map display (https://www.mapbox.com/). The information about your property as well as your name and e-mail address are required data, the entry of a telephone number is voluntary unless otherwise described. We need this information to process your request, to address you correctly, to authenticate you and to provide you with the value indication. After you have entered your personal data, agreed to the data processing and contact and clicked on the "Request" button, Sprengnetter will automatically send you a link to the value indication created by Sprengnetter to the e-mail address you have provided. Sprengnetter will automatically create the requested value indication on the basis of the address and property data provided. After a short confirmation you can call up the value indication. Upon confirmation, the data you entered will be forwarded to us together with the link to the value indication so that we can contact you. We will then contact you by e-mail or telephone and explain the contents of the value indication, advise you on the preparation of a detailed market price calculation, if necessary, and offer you our support in marketing your property. X.2 Legal basis for the processing of personal data The legal basis for data processing is your consent pursuant to Art. 6 Para. 1 lit. a DSGVO or our legitimate interests pursuant to Art. 6 Para. 1 S. 1 lit. f. Your consent can be revoked at any time with effect for the future. X.3 Purpose of processing In order to carry out and provide the value indication, we process your personal and property-related data that you have provided in the application. We need your e-mail address in order to send you the link to the created value indication. In addition, we process your e-mail address or your telephone number (if provided) in order to contact you in writing or by telephone for the purpose of explaining the value indication and, if necessary, to advise you with regard to services based on it. X.4 Duration of storage The data will be deleted or its processing restricted (blocked) as soon as it is no longer required to achieve the purpose for which it was collected or the data subject has objected to this processing. Please also note that we may have to retain certain data for a specified period of time in order to comply with legal requirements (e.g. tax regulations).

## Object proofs (broker contracts for purchase objects)

At a viewing, fill in a statement confirming the proof of the object by us. This proof serves to secure our commission upon conclusion of the contract (see Terms and Conditions) and takes place during the inspection. It contains information about yourself, your signature and information about the object you are visiting. Object proofs will be deleted after successful sale or purchase at the latest 30 years after successful placement. Object evidence that does not need to be kept for billing purposes (if no sale took place), a maximum of six years (§ 257 I HGB) are kept.

#### Contracting for a rental property

For the contract initiation a so-called "self-information" from the prospective tenant is required. The data contained therein are not transmitted via this website by the user to us, but by means of a form that is filled in by hand and handed over to us personally or transmitted by post, fax or e-mail. You may also be required to provide other personal information documents that form the basis of the rental or purchase agreement (such as Schufa information, salary statements, credit reports, etc.). The data will be transmitted exclusively to the respective contracting parties (for example landlord or seller). The statutory retention periods apply (§ 257 I HGB).

#### **Accounting**

For our invoicing and tax accounting billing data are transmitted to our external service provider and stored according to the statutory retention periods. When ordering, we comply with the statutory provisions in accordance with Art. 26 ff. EU DSGVO.

#### Use of reCAPTCHA

To protect entry forms on our site, we use the service "reCAPTCHA" from Google Ireland, below named "Google". Through the use of this service, it can be distinguished whether the corresponding input is of human origin or abused by automated machine processing.

To our knowledge, the referrer URL, the IP address, the behavior of the website visitors, information about the operating system, browser and duration, cookies, presentation instructions and scripts, the input behavior of the user and mouse movements in the "reCAPTCHA" checkbox to "Google" transfer.

Among other things, Google uses this information to digitize books and other printed matter, as well as to optimize services such as Google Street View and Google Maps (eg house number and street name recognition).

The IP address submitted as part of "reCAPTCHA" will not be merged with any other data provided by Google unless you are logged in to your Google Account at the time you use the "reCAPTCHA" plugin. #### **Credit checks**

The purpose is to verify the creditworthiness of requested person. The legal basis for processing is Art. 6 para. 1 lit. f EU-GDPR. Information about this data may thereafter only be obtained and granted, if a legitimate interest in the knowledge of this information is credibly set forth.

## Rights of persons concerned

You have the right:
